
1. Introduction

Expertise Demonstration

A professional interview is conducted to assess the applicant's communication skills, teaching and training philosophy, and overall suitability to become an Edupro Recognised Trainer. Applicants may be asked to demonstrate their expertise through a presentation or practical session to showcase their ability to effectively convey information and engage learners.

5.3. Fees and Payment

Upon receiving confirmation from the Quality Assurance (QA) team as part of the recognition process, a payment of GBP 1,000 is required. This fee contributes to the administrative and quality assurance costs associated with the recognition process. Upon successful payment, you will be issued a Certificate of Recognition, a sample of which is provided in Appendix 2. The certificate formally acknowledges your status as an Edupro Recognised Trainer. This payment is a one-time fee per year and non-refundable.

5.4. Recognition Notification and Continuous Monitoring

The final step involves obtaining endorsement from Edupro, a UK awarding organisation, adding an additional layer of validation to the recognition process. Successful applicants are notified of their recognition as Edupro Recognised Trainer (with a certificate of appreciation, sample given in Appendix 2).
