

### 3. Edupro and its recognition logos

### 3.1. Edupro Logo

The Edupro logo is designed to embody the organisation's commitment to education, professional development, and innovation.

# Edupro Logo is created by a word-mark (logotype) and a symbol mark. Always use the logo files provided. Do not re-create. Edupro Logo can also be accompanied by a tagline.

### Uses of Edupro logo

- Edupro logo can be used by Edupro approved centres or partners in following circumstances:
  - o Only on the Certificate that are issued by Edupro
  - o On centre's website to show as a partner- 'Edupro logo with website address tagline'
- Use of Edupro logo is completely prohibited in any other situation without written permission from Edupro.

In addition to its main business logo, Edupro provides three distinct types of recognition logos, each tailored to signify specific recognition statuses for stakeholders: Education Institute, Employer and Trainer. Each logo serves as a mark of credibility, professionalism, and adherence to Edupro's high standards, ensuring stakeholders can visibly demonstrate their association with Edupro's quality assurance framework.



### 3.2. Edupro Learning & Exam Centre Logo

This logo is exclusively designed for institutions CENTRE RECOGNITION approved as Edupro Positive version Negative version Learning & Exam Centres. It symbolises the institution's commitment to Learning & Exam Centre **Tedupro Tedupro** delivering and assessing Edupro qualifications with integrity and quality assurance.

### **USES**

- Centre Website: Showcase the institution's partnership with Edupro and its approved status. Create link to our website to make it easier for your users to find out more about us and to identify the Awarding Organisation responsible for the qualifications. The recognition logo can be linked to Edupro website or to any particular Edupro qualification page.
- Marketing Materials: Include in brochures, banners, compliment slips and business cards and other promotional content to attract students and stakeholders.
- Signage: Place on premises to signify Edupro's recognition.
- Social media and Email: Use online and on social media platforms owned by the Centre to
  advertise that they are recognised to deliver Edupro qualifications and assessments. The
  logo may be used on email, signatures and in the body of an email to promote that a Centre
  is recognised to deliver Edupro qualifications.

### **RESTRICTIONS**

• Prohibited on Certificates: This logo must not appear on any certificates issued by the centre.

### 3.3. Edupro Recognised Employer Logo

This logo is designed for employers demonstrating alignment with Edupro's quality standards by supporting employee training, skills development, and professional growth.



### **USES**

- Corporate Website: Highlight recognition as an Edupro partner in professional development.
   Create link to our website to make it easier for your users to find out more about us and to identify the Awarding Organisation responsible for the qualifications. The recognition logo can be linked to Edupro website or to any particular Edupro qualification page.
- Recruitment Materials: Feature in job postings and promotional materials to attract talent.
- Company Profile: Include in presentations and public-facing documents to signify credibility.
- Marketing Materials: Include in brochures, banners, compliment slips and business cards and other promotional content to attract employees and stakeholders.
- Social media and Email: Use online and on social media platforms owned by the organisation
  to advertise that they are recognised to deliver Edupro qualifications and assessments. The
  logo may be used on email, signatures and in the body of an email to promote that the
  organisation is recognised to deliver Edupro qualifications.

### **RESTRICTIONS**

• The logo cannot imply direct involvement in delivering Edupro qualifications and hence cannot be used on the certificate.



### 3.4. Edupro Recognised Trainer Logo

This logo is awarded to individual trainers meeting Edupro's rigorous training and assessment standards. It reflects their professional expertise and commitment to quality.



### **USES**

- Trainer's Website or Portfolio: Demonstrate recognition as an Edupro-certified trainer.
- Professional Profiles and Social Media: Use on LinkedIn, resumes, and personal branding
  materials. Use online and on social media platforms owned by the organisation to advertise
  that they are recognised to deliver Edupro qualifications and assessments. The logo may be
  used on email, signatures and in the body of an email to promote that the organisation is
  recognised to deliver Edupro qualifications.
- **Promotional Materials**: Included in flyers, business cards and online content to promote training services.

### **RESTRICTIONS**

 This logo must not appear on certificates or imply unauthorised delivery of Edupro qualifications.



### 4. QA and Certificate Type

We are providing the quality assurance services and certification services for your own qualification or training programmes that you are offering to local markets. We know 'one size does not fit all'. If standard qualifications do not meet your demand, you may take our Edupro Quality Assurance Service. For these programmes, we recognise the robust quality assurance systems that the centres have in place and apply to these programmes.

By obtaining Edupro Quality Assured certificate from UK, your learners will receive a globally recognised badge that demonstrates your dedication to maintaining high-quality standards.



### Certificate of Achievement

Ensures the quality of learning from a course, tailored to meet specific objective.



### Certificate of Completion

Provides the evidence of your learners' skill and knowledge progression in short courses.



### Certificate of Attendance

Officially recognised badge for short or full-day training programmes.

### 5. Full Logo Appearance and Size

### Legibility

An exclusion zone around the logo has been created to protect its integrity and make sure the logo is easy to read. The height of the "e" of the logo is taken as a guide to define the exclusion zone.




There is no maximum size for the logo.

### Misuse of Logo

Don't change the logo structure, colour, proportions or elements.

Maintain proper exclusion zone.

As the logos represent our Recognised Centre status, maintaining their consistent appearance is essential to ensure they remain recognisable to the public. The logos must not be altered or misused in any way. Any incorrect formatting of the logo should be strictly avoided.



### Some Do's

- ✓ Do use our logo
- ✓ Do link to our website
- ✓ Do show users clearly who is providing the qualification and allow them to easily find out more about us
- ✓ Do let us know of good, relevant content from your website we can use to provide reciprocal links - e.g. News stories involving our courses/learners
- Do include us in lists of Awarding Organisations you work with or are recognised by.
- ✓ **Do** use our courses as a selling point for your organisation
- ✓ Do blog and Tweet about us
- ✓ Do recommend us to others
- Do ask yourself if a user could be misled by the way you're using our logo or name
- ✓ Do ask us for help if you're unsure
  - ✓ Do send us a copy of how you're planning to use our logo or name before publication
  - ✓ Do keep our logo in proportion and its original colours

### Some Don'ts

- Don't distort or change the colour of our logo
- Don't use our logo to imply approval/accreditation of provision which is not ours.
- Don't use our logo to imply endorsement of the organisation as a whole, especially if you offer provision from other AOs or nonaccredited training.
- Don't use words such as "qualification" if the provision is not a regulated qualification, e.g. accredited units.
- Don't make exaggerated or unsubstantiated claims about our courses

### 6. Dual Branded Certificate

For our Quality Assured Services, Edupro may issue dual-branded certificates to acknowledge the successful completion of qualifications or training. These certificates will display both the customer's logo and the Edupro logo and can be provided as printed certificates and/or e-certificates. Below are the conditions and guidelines for using both logos on these certificates:

### 1. Customer Logo Usage

- The customer's logo may be included on the certificate only if the customer holds national recognition for awarding certificates. This ensures that the logo placement is appropriate and aligned with the customer's certified status.
- The customer's logo must be provided in a high-resolution format (e.g., .png, .jpg, or .eps),
   ensuring it is clear and properly rendered in both printed and digital versions.
- The use of the customer's logo must adhere to the guidelines set by Edupro in terms of size, spacing, and positioning, to maintain consistency and visual integrity.

### 2. Edupro Logo Usage

- The Edupro logo must appear on the certificate, and its placement should be consistent with Edupro's branding guidelines and would be balanced with the customer's logo.
- The Edupro logo must not be altered in any way, including resizing or colour modification, without prior approval from Edupro.
- The placement of Edupro's logo should follow the designated areas as per the official Edupro branding guidelines, ensuring the logo's visibility and legibility across all certificate formats.

### 3. Placement and Proportions

- Both logos (Edupro's and the customer's) should be placed on the certificate in a way that
  respects visual hierarchy. The logos should be sized appropriately to maintain balance, with
  neither logo being disproportionately large or small.
- The logos should be placed with sufficient clear space around them to ensure they remain distinct and legible. Specific clearance distances should be defined in the Edupro branding guidelines.

### 4. Approval Process

- Any use of the customer's logo alongside Edupro's logo must be approved in writing by Edupro to ensure that all branding adheres to Edupro's guidelines.
- Edupro reserves the right to review and approve the **final design** of any dual-branded certificate before it is issued to ensure consistency with Edupro's standards and maintain the integrity of the brand.

### 7. Terms of usage

Edupro reserve the right to change logos and branding at any time. We will provide Centres with updated material where necessary. Edupro will regularly check that Centres are using the logo appropriately and in line with these guidelines.

Centres must respond in a timely manner to requests for changes relating to the use of the logo. Edupro reserve the right to enter into legal proceedings against Centres found to be using the Edupro brand inappropriately or outside of the agreed terms.

Edupro may also revoke approval if Centres are found to be using the Edupro brand inappropriately.
